Complete the application below and present it to the Village Clerk's Office at 4 N. Ten Broeck Street. All applicants must show proof of a valid dog license as well as current distemper vaccinations. For Scotia and Glenville residents, dog licenses are obtained from the Town of Glenville Clerk's Office, 18 Glenridge Road, Glenville. Upon acceptable presentation of all documentation and payment of applicable fees, a dog park permit will be issued. Permitted dogs must display both their dog park permit tag and dog license tag while using the park. Dog Park permits are annual permits expiring December 31<sup>st</sup> of each calendar year. Permits must be renewed each year for continued use. No refunds will be issued.

I hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal and expert witness fees) by reason of any claim or liability that may result from any use by me, the person in custody of my dog(s) and/or my dog(s) for damage because of bodily injury, including death at any time resulting therefrom, sustained by any person or persons, including myself or on account of damage to property arising out of or in consequence of the use of the dog park, howsoever such injuries, death or damage to property or person may be caused and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or agents, or any other persons.

I agree to carefully inspect and satisfy myself that the facilities provided are safe for their intended use. Once having conducted the inspection I agree to expressly assume all risks for myself, my children and my dog(s) participating at these premises. I understand the dog park is not supervised.

I acknowledge receipt of a copy of the Rules and Regulations for the Village of Scotia Dog Park and I have read and fully understand them and agree to abide by them.

I have read this Release/Waiver of Liability and assumption of risk for using the Village of Scotia Dog Park and understand, agree and accept its terms and conditions as indicated by my signature.
